Centralized Environment Support for NRC Application Systems and Environment

On July 18, 2011, as a result of a full and open competitive solicitation, a hybrid-type (fixed price/labor hour) Indefinite-Delivery Indefinite-Quantity contract (NRC-HQ-11-C-33-0056) was awarded to Vistrionix, Inc. of Reston, Virginia, to provide centralized environment support for NRC Application Systems and Environment. The period of performance is July 20, 2011, through July 19, 2012, with six 1-year options to extend the term of the contract and three 1-year award terms. The total estimated ceiling cost is \$12,000,000, inclusive of all options and award terms.

Consideration of Rulemaking to Address Prompt Remediation of Residual Radioactivity During Operations: Notice of Public Webinar and Request for Comment, 10 CFR Part 20 (NRC-2011-0162)

On July 18, 2011, the NRC published a notice of public Webinar and request for comment regarding a potential rulemaking (76 FR 42074) in the *Federal Register* seeking input from the public to address prompt remediation of residual radioactivity during the operational phase of licensed material sites and nuclear reactors. The NRC has not initiated a rulemaking, but is in the process of gathering information for developing a technical basis document. The NRC is requesting comments on the issues discussed in the document by September 16, 2011. The public Webinar will be held on July 25, 2011, at 1:00 p.m. to facilitate public understanding of the issues and the submission of comments.

Alternative to Minimum Days Off Requirements; Final Rule, 10 CFR Part 26 (NRC-2011-0058)

On July 21, 2011, the NRC published a final rule (76 FR 43534) in the *Federal Register* amending its regulations governing the fitness for duty of workers at nuclear power plants. These amendments allow holders of nuclear power plant operating licenses the option to use a different method from the one already prescribed in the NRC's regulations for determining when certain nuclear power plant workers must be afforded time off from work. This is to ensure that such workers are not impaired due to cumulative fatigue caused by work schedules. The final rule is effective August 22, 2011.

Meeting with National Archives and Records Administration, Controlled Unclassified Information (CUI) Executive Agent (EA)

On July 18, 2011, staff from the Information and Records Services Division met with representatives from the CUI EA. The purpose of the meeting was to discuss the NRC's CUI compliance plan project and to review draft elements the EA would like to see included in agency compliance plans. The EA staff was complimentary of the NRC's progress in developing its plan, stating that NRC is ahead of most agencies. Compliance plans are due to the EA on December 6, 2011, after which the EA will review them and, in consultation with affected agencies and the Office of Management and Budget, will establish deadlines for phased implementation by agencies.

Council of Agency Paperwork Reduction Act (CAPRA) Officers Monthly Meeting

On July 21, 2011, staff from the Information and Records Services Division attended a meeting convened by the CAPRA Officers at the Treasury Department. Agenda items included a live demonstration of the new common-forms module in the Regulatory Information Service Center, Office of Information and Regulatory Affairs Consolidated Information System, and a live demonstration of the CAPRA website in the Max Community led by a representative from the Office of Management and Budget. Common forms are generic forms usually developed by the Office of Personnel Management and used by all Federal agencies. The new common forms module will require agencies to account for burden associated with the use of these forms as part of agency information-burden collections. Currently, such burden as NRC staff using common forms is not included in the NRC annual burden collection report but under the new forms module such a burden would need to be included. The new module is expected to roll out in November 2011. The Max Community demonstration of the CAPRA web site showed it to be an excellent tool to collaborate with fellow CAPRA members and those in the Paperwork Reduction Act arena.

Limited Appearance Statement Session for AREVA Eagle Rock

The Atomic Safety and Licensing Board (ASLB) held a limited appearance statement session in Idaho Falls, Idaho on Monday, July 11, 2011. Fourteen people provided oral statements. Most comments were supportive of the facility. Concerns raised included the need for the facility and whether it is prudent for the Department of Energy to provide a loan guarantee to a French company.

Licensing Board Visits Proposed AREVA Eagle Rock Site

On July 11, 2011, the ASLB visited the proposed site for the Eagle Rock Enrichment Facility and the nearby Hell's Half Acre. AREVA Enrichment Service's led the site visit and described the layout of the proposed facility. NRC staff and representatives of the Snake River Alliance also attended.

Mandatory Hearing for AREVA Eagle Rock Enrichment Facility

From July 12-13, 2011, the ASLB held the mandatory hearing on the Environmental Impact Statement for the AREVA Eagle Rock Enrichment Facility. The hearing was held in Idaho Falls, Idaho. Six presentations covered the purpose and need for the facility; preconstruction activities; greenhouse gas impacts of the facility's production power consumption; construction air quality impacts; effluent and environmental monitoring programs; and the status of the Memorandum of Agreement for cultural and historic resources. The Board is scheduled to provide its decision in September 2011.

Public Meeting on American Society of Mechanical Engineers (ASME) Code Case N-770-1

On July 12, 2011, staff held a Category 2 public meeting to discuss the implementation of ASME Code Case N-770-1 and provide an opportunity for questions and answers concerning the use of the code case. Use of this ASME code case was made mandatory, along with certain limitations imposed by the NRC, effective July 21, 2011. Participants were encouraged to ask questions at the meeting and to forward the questions electronically to the staff. Preliminary answers were provided to questions during the meeting, and a publicly available response to all questions received will be compiled and made available along with the meeting summary within 30 days of the meeting.

Issuance of the Renewed Operating License for Hope Creek Generating Station

On July 20, 2011, the operating license for the Hope Creek Generating Station was renewed, authorizing operation for an additional 20 years beyond the original license expiration date. The new expiration date is April 11, 2046. The staff completed its review as documented in the Safety Evaluation Report, NUREG-2102, published June 2011 and the Supplemental Environmental Impact Statement, NUREG-1437, Supplement 45, published March 2011. The issuance of the Hope Creek Generating Station renewed license brings the total number of renewals to 71 reactor units.

NRC-specific Symposium at the American Society of Mechanical Engineers (ASME) Pressure Vessel and Piping (PVP) Conference

RES staff organized and chaired the “ASME Code Process and Incorporation into Regulations” symposium at the ASME PVP Conference in Baltimore, Maryland on July 19, 2011. The symposium consisted of a series of keynote presentations made by NRC management followed by a panel session on Nuclear Codes and Standards consisting of NRC and ASME panelists who discussed issues related to new reactors, operating reactors, license renewal, materials and operational leakage. Two additional Panel Sessions followed covering recent developments in ASME Code Section III, e.g. High Density Polyethylene Piping, Fusion Facilities, and High Temperature Reactors.

Meeting on Weld Residual Stress (WRS) Finite Element Analysis (FEA) Validation Program – Results of the International Round Robin:

On July 20, 2011, RES staff hosted a meeting of 40 participants from nine countries, representing 27 organizations from industry, academia, research institutes, and regulatory bodies on the results from the NRC Dissimilar WRS Validation Program – International Round Robin. NRC developed, coordinated, and hosted an international blind round robin comparison between WRS models used in flaw evaluations to actual WRS measurements. The meeting was held at the 2011 ASME PVP Conference in Baltimore, Maryland.
