

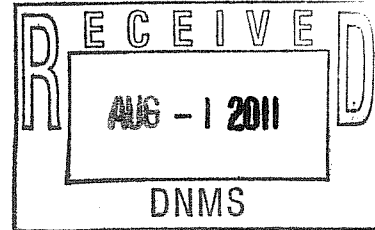

This letter is to request an amendment to the corrected license you sent to the Bureau of Reclamation changing our license from an "open-ended" possession limit to a "closed-ended" possession limit. We are asking to change our possession limit on item 8 from 24 millicuries total to 48 millicuries total for the Cesium-137 sealed source, and from 120 millicuries to 240 millicuries total for the Americium-241 sealed source.
