MACTEC Development Corporation (MACTEC) is providing written notification, as required by Materials License, Number 05-27748-01, Docket Number 030-36204, that licensed activities at the Hunters Point Shipyard, located in San Francisco, California have been completed.

MACTEC implemented its license to control radiological activities that included the demolition of radiological and dilapidated shoreline wooden structures comprising of Berths 61 and 64, Piers B and C, the wood portions of the quay wall adjacent to Pier C, and Wharf No. 2 between Dry Docks 2 and 3. No licensed radioactive material remains at the temporary job site as documented by radiological surveys performed between 03/07/2011 and 07/29/2011.

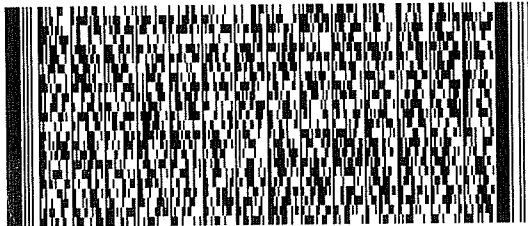

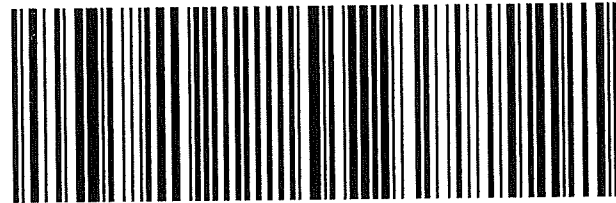
