

NRC License 37-07676-02 authorized the possession and use of Antimony 124 sealed sources in two Boulder Scientific Model 200 Analyzers at Cabot's Reading (PA) facility located on Tuckerton Road, Muhlenberg Township, Berks County. This facility, including all equipment, was sold by Cabot to NGK Metals Corporation. The Antimony 124 sources on hand at the time of the sale were transferred to NGK Metals Corp. as part of the two analyzers.

Facility personnel contacted the NRC regional office to discuss how NRC wanted to handle the change of ownership from a licensing standpoint. As a result of these discussions, the facility was issued a new license number: 37-28124-01. Apparently due to an oversight, however, the old license (37-07676-02) which covered the same facility and sources as the new license, was not officially terminated. Cabot is hereby requesting such termination.

NGK Metals Corporation continued to operate the instruments, so no radiation survey was conducted to confirm the absence of radioactive contamination. At the time of the transfer, the sealed sources were within the six months swipe test requirement.
