Gentlemen:

This refers to your letter dated April 24, 1987, informing the Commission that NGK Metals Corporation has purchased the Reading facility of Cabot Corporation, Wrought Products Division.

If Cabot Corporation was purchased in its entirety by NGK Metals Corporation, and if Cabot Corporation will not continue in business as a separate entity, the change of ownership will be processed as an amendment to Materials License 37-07676-02, for which an amendment fee of \$60 is required as specified in fee Category 3P of \$170.31 of the enclosed 10 CFR 170. However, if Cabot Corporation will continue in business as a separate entity, it will be necessary for NGK Metals Corporation to obtain a new license, and Cabot Corporation should request termination of their current license. A copy of NRC Form 313 is enclosed for your use in applying for the new license, if appropriate. You should contact the Region I Licensing staff at the address listed on the NRC Form 313 for copies of regulatory guides and other licensing information. The application for a new license should be accompanied by an application fee of \$230 as specified in fee Category 3P of \$170.31.

The clarifying information for the amendment, or the completed application form for the new license, as applicable, should be mailed to my attention at our Washington, D.C address and should be accompanied by the appropriate fee specified above. Upon receipt of the additional information and fee, your application will be forwarded to the Region I Licensing staff for processing.
