SUBJECT: SUMMARY OF THE JULY 12, 2011, PUBLIC MEETING WITH
STAKEHOLDERS TO DISCUSS THE ELECTRIC POWER RESEARCH
INSTITUTE'S (EPRI'S) TOPICAL REPORT (TR), WCAP-17096,
REVISION 2, "REACTOR INTERNALS ACCEPTANCE CRITERIA
METHODOLOGY AND DATA REQUIREMENTS" (TAC NO. ME4200)

On July 12, 2011, the U.S. Nuclear Regulatory Commission (NRC) held a Category 2 public meeting with stakeholders. The purpose of the meeting was to discuss the NRC's request for additional information (RAI) (Agencywide Documents Access and Management System (ADAMS) Accession No. ML111160066) regarding EPRI's TR WCAP-17096, Revision 2 (ADAMS Accession No. ML101460157). The meeting was intended to cover the information needed by the NRC to continue the review and potential endorsement of the TR through a safety evaluation (SE).

The discussions included; introductory remarks by NRC and industry, a discussion by the Pressurized Water Reactor (PWR) Owners Group (PWROG) covering the potential impact of the RAIs to the TR, and a discussion of the impact of the issuance of the final SE for EPRI's TR "Materials Reliability Program: Pressurized Water Reactor (PWR) Internals Inspection and Evaluation Guidelines (MRP-227-Rev. 0)" (ADAMS Accession No. ML090160206), that is referenced in TR WCAP-17096. The industry provided some examples of what the impacts would be to the TR and some of the proposed changes that would need to be made.

Although the intent of the meeting was to provide an opportunity for industry to ask clarifying questions on the RAIs, considerable time was spent discussing the impact and changes to the TR that would be required by the RAIs. The industry committed to provide a proposed schedule by August 1, 2011, to respond to the RAIs.

The meeting was well attended by 6 NRC staff members and 18 industry representatives. Enclosed is the Attendees List.
