In accordance with the DAEC Technical Specifications, Section 6.11.2A.1, this letter is intended as notification of an abnormal occurrence at the Duane Arnold Energy Center on January 17, 1975. This letter, telecopied to your office, is intended to satisfy the requirements for notification by telegram within 24 hours of an abnormal occurrence.

Identification of Occurrence

RHR A > B pressure differential indicating switch settings, reportable in accordance with Appendix A, Operating License DPR-49, Specifications 1.0.4.b and Table 3.2-B.

Description of Occurrence

During the performance of Surveillance Test Procedure No. 42B017 - RHR A7B dP Across Riser Instrument Functional Test/Calibration (LPCI Loop Selection Logic) was determined that PDIS 4644 had a trip setting of 0.2 psid.

The Technical Specification Limit is 0.5 $\,<\,p\,<\,1.5$ psid. The switch was immediately recalibrated.

As previously discussed with Mr. C. D. Feierabend of your office, the formal report on this abnormal occurrence will be included in the Supplemental Report for Abnormal Occurrence No.'s AO 50-331/74-48, 74-51 and 74-52.
