Identification of Occurrence


Out-of-specification reactor low pressure switch, reportable in accordance with Appendix A, Operating License DPR-49, Specification 1.0.4.b.

Description of Occurrence

During the performance of STP 42B007 - Reactor Low Pressure (CS, RHR) Instrument Functional Test and Calibration, Pressure Switch 4529 was found to have a trip point of 433 psig. The Technical Specification Limit is 456.7 ± 15 psig. (450 psig setpoint + 6.7 psig head correction ± 15 psig design instrument tolerance).

PS 4529 was immediately recalibrated.

Investigation is continuing.
