


Reference Task Order HR-001 under Contract NRC-10-07-414 for temporary secretarial support.

The purpose of this modification is to (1) extend the period of performance of this task order, (2) increase the task order ceiling, (3) revise the price schedule, and (4) add incremental funding, as follows:

1. The period of performance end date of this task order is extended from September 20, 2011, to September 20, 2012, an extension of one year, in order to continue the effort under this task order during option year four of Contract NRC-10-07-414. The revised period of performance is from November 1, 2007 through September 20, 2012.

2. Increase the ceiling of Task Order HR-001 by \$159,993.67, from \$516,083.79 to \$676,077.46.

3. An estimated price schedule showing revised Option Year Three and new Option Year Four, as well as the total task order ceiling in the amount of \$676,077.46, is attached.

4. Add incremental funding in the amount of \$184,609.00 (\$41,407.00 + \$143,202.00), thereby increasing the obligated amount from \$463,084.88 to \$647,693.88.
