On June 29, 2011, from 10:00 a.m. to 11:00 a.m., the U.S. Nuclear Regulatory Commission (NRC) conducted a pre-decisional enforcement conference (PEC) with representatives of GeoConcepts Engineering, Inc. (GCE) at the NRC Region I office in King of Prussia, PA. The NRC conducted the PEC, at GCE's request, to discuss an apparent violation that was identified during an NRC inspection of GCE conducted on March 14, 2011 through April 21, 2011. The apparent violation involved the failure to use a minimum of two independent physical controls that form tangible barriers to secure a portable gauge from unauthorized removal, whenever the portable gauge was not under the control and constant surveillance of the licensee as required by 10 CFR 30.34(i).

A notice of the public meeting was issued on June 16, 2011, and was posted on the NRC's external (public) web page (ADAMS Accession No. ML111670014)

The NRC presented and discussed its assessment of the finding significance as documented in NRC Inspection Report 03035002/2011001 (ADAMS Accession Nos. ML111430760 and ML111430764). The representatives of GCE described their views on the finding. GCE also discussed the corrective actions that have been taken to correct the issue and prevent recurrence. A member of the public observed the meeting via teleconference and was provided an opportunity to ask the NRC staff questions after the PEC was completed, but before the meeting adjourned.
