This letter, telecopied to your office, is intended to satisfy the requirement for prompt notification of a Reportable Occurrence in accordance with Specification 6.11.2.a of the Duane Arnold Energy Center Technical Specifications.

Technical Specification paragraph(s) violated:

Description Occurrence: During a weekly maintenance inspection, the oil drain petcock on the governor for standby diesel generator 1G-31 was found open slightly and no oil level was indicated on the governor sight glass. The petcock was closed fully and approximately one half pint of oil was added to the governor to restore normal level to the sight glass. Additional corrective actions are being reviewed.
