Dear Mr. Keppler:

This letter is in response to W. L. Fisher's letter concerning an inspection of activities at the Duane Arnold Energy Center conducted on November 14-18, 1977. The following response indicates the action which has been or will be taken to correct the items of noncompliance identified in Mr. Fisher's letter.

Infraction

Contrary to Technical Specification 6.8.1.2, refueling procedure No. 16, and Plant Radiation Protection Manual, Section 6.9, certain licensee employees failed to comply with radiation work permit requirements.

Response

1. Corrective action taken and the results achieved:

Immediately following the April 4, 1977 incident, a management meeting was held to discuss the situation and resolve any problem areas. Due to a misunderstanding in this meeting, a similar incident occurred on April 7, 1977. Another management meeting was held following the April 7, 1977 incident at which time the Chief Engineer clearly stated the responsibilities of all individuals towards Radiation Protection policies. Since this second meeting, no incidents have reoccurred.

2. Corrective action to be taken to avoid further noncompliance.

The action taken in 1) above has been sufficient to avoid any further noncompliance. It should be noted that of 13 NRC Inspections at DAEC for the Radiation Protection department, only four (4) minor deficiencies



and four (4) minor infractions were found for the entire year of 1977. This small amount of noncompliance indicates that the Infraction for this letter is an isolated situation.
