

Dear Dr. Murley:

The following describes our plan for the implementation of Revision 4 of the BWR Owner's Group Emergency Procedure Guidelines. After discussions with members of the NRR staff, we have decided not to formally submit a revised version of the Emergency Operating Procedure (EOP) Generation Package (PGP) for NRC review. We understand that the NRC has completed its review of our previously submitted PGP (November 16, 1984) and will be forwarding comments on the content of that PGP to Iowa Electric. These comments will be reviewed to ensure that they have been fully resolved in the revised PGP which will be maintained as an auditable document available for NRC review. The revised EOPs will be fully implemented by July 7, 1989. Major milestones for this implementation schedule are listed below.

1. The revised EOPs have been developed and a validation process was completed in August, 1988. A final verification is currently in progress and will be completed by March 13, 1989.

 An independent Quality Assurance audit will be performed on the revised EOPs to assure that the procedures and the verification and validation process are in agreement with the revised Procedure Generation Package. The audit is scheduled to begin on March 13, 1989 and be completed by March 31, 1989.

3. Operator training requirements have been identified. Classroom training of Licensed Operators on the revised EOPs will begin on February 27, 1989 and be completed by April 3, 1989.

4. Simulator training of Licensed Operators on the use of the revised EOPs will begin on April 6, 1989 and be completed by June 24, 1989.

5. Formal issuance of the revised EOPs will be completed by July 7, 1989.
