The purpose of this modification is to: (1) exercise Option Year One, (2) provide incremental funding in the amount of \$40,709.00, which increases the obligated amount from \$169,342.84 to \$210,051.84, and (3) increase the ceiling by \$166,464.06, from \$169,342.84 to \$335,806.90.

Accordingly, the following changes are hereby made:

1. Section A.3 CONSIDERATION AND OBLIGATION—TIME AND MATERIALS, paragraph (a) and (b) are hereby deleted in their entirety and replaced with the following:

(a) The total estimated amount of this contract (ceiling) under this contract is \$335,806.90.

(b) The amount presently obligated with respect to this contract is \$210,051.84. The obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling as specified in paragraph (a) above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.

1. Effective with the date of this modification, Article A.5 – DURATION OF CONTRACT, is revised as follows:

The period of performance for this contract is August 11, 2010 through August 10, 2012.
