

The purposes of this modification are to obligate funds in the amount of \$180,000 and the increase the ceiling price by \$299,824.80. Therefore, this modification hereby increases the obligated amount by \$180,000 from \$1,497,000.00 to \$1,677,000 and the ceiling price is hereby increased by \$299,824.80 from \$1,515,143.87 to \$1,814,968.67.
