Your NRC license expiration date was extended to afford you ample time to resubmit your termination request and address the issues that were discussed via phone and email with Heather Ramsey and Barbra Dotson. Basically what is needed is a history of work conducted under this license and evidence that facilities where work was performed are not contaminated. A final status survey and information concerning instrumentation used to perform final status survey(s) and calibration history of instruments will suffice. If you decide to renew your NRC license, please resubmit your renewal application and address the issues that are attached to this letter.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.


