Please note that you can resubmit the documents that were submitted to the NRC in the past, however, any documents resubmitted to the NRC need to have up-to-date and accurate information representing the current licensed activities and products.

1. 10 CFR 30.33 requires you to apply for and obtain a specific license authorizing possession and use of radioactive materials from the States wherever licensed material are possessed. Please submit a copy of your current States of California, Kentucky, Pennsylvania, New Hampshire and Puerto Rico licenses.
2. Please update you submitted document dated February 23, 2001 to reflect you current locations of distribution, and remove the expired states' licenses.
3. Please resubmit the document dated December 22, 2008, because this document could not be located in our database. We apologize for the inconvenience.

We will continue our review upon receipt of this information. If we do not receive a reply from you within 30 calendar days from the date of this letter, we will assume that you do not wish to pursue your application.
