

#### Amendment 10-A

"Duane Arnold Energy Center Final Safety Analysis Report"

Answers to D L Letter of November 30 re: Financial Information

1. Estimated annual costs to operate the unit are as set forth in Table 1.

In accordance with accepted accounting practice and the Uniform System of Accounts prescribed by the Federal Power Commission, interest costs on the investment in the Duane Arnold Energy Center are neither accounted for as, nor considered to be, an operating cost of the facility by any of the applicants. Rather, such costs are a general obligation of each of the applicants and funds for the payment of such obligations will be derived from general revenues of the applicants. (A)

All operating costs of the DAEC will be apportioned among the applicants in the ratio of their respective ownership interests. The funds to be provided by each applicant to meet its share of the operating costs will be derived by each applicant from its overall operations. (B)

(A) The annualized interest on all long-term indebtedness outstanding and net investment in utility plant of the applicants, on an actual and a pro forma basis, at October 31, 1972, are set forth in Table 2.

(B) No specific operating revenues are earmarked by an applicant to meet the expenses relating to any particular facility, such as the DAEC. It may be noted, however, that anticipated kilowatt hours to be generated at the DAEC, priced at current average revenue per Kwh of the respective applicants, would yield annual aggregate revenues as follows:

1974	\$65,981,800
1975	58,999,100
1976	69,700,500
1977	71,209,900
1978	66,017,900

Actual revenues arising from sales of power generated at the DAEC will depend upon actual kilowatt hours generated, rate schedules then in effect and types of sales actually made (wholesale, commercial, residential, etc.). It should also be recognized that power generation anticipated at the DAEC will replace in part present generation from existing facilities with certain continuing costs.

2. The estimated cost of permanently shutting down the Duane Arnold Energy Center at the conclusion of its useful life is estimated at \$9,750,000, based on 1972 dollars.

The decommissioning activities following the final shutdown would consist of the following major steps:

Removal of all fuel from the site,

Removal of all radioactive wastes from the site,

Decontamination by chemical cleaning and flushing of the various components, piping, etc., and removal of the resulting radioactive wastes from the site,

Capping/sealing of the following items to completely close them after removal of all salvageable components:

- a) Reactor head
- b) All lines connecting to the reactor vessel
- c) Drywell head and all accesses
- d) All lines exterior to the drywell for radioactive systems
- e) Fuel Pool (by installing cover)
- f) All potentially contaminated vessels (e.g., demineralizers, storage tanks, etc.)
- g) All doors, penetrations and other accesses to all buildings containing radioactive equipment
- h) Access to all remaining structures

Demolition of stack,

Additional fencing to fully enclose the area of significance.

Funds for this endeavor will be derived from the overall operations of the applicant and the co-applicants.

3. Estimated annual cost in 1972 dollars to maintain the facility in a safe shutdown condition is \$200,000. This includes a 24 hour security force and expected inspection and maintenance. Funds for this endeavor will be derived from the overall operations of the applicant and the co-applicants.

4. Neither the participation of the applicant nor either of the co-applicants is contingent upon receipt of funds from any entity. 5. Prospectuses for Iowa Electric's recent security issues are attached. The coapplicants do not issue securities and therefore have no prospectuses.

6. Annual reports for 1971 for the applicant and each of the co-applicants are attached.

7. The applicant and the co-applicants will share the (1) cost of operation, (2) cost of permanent shutdown and (3) cost to maintain a safe shutdown condition in the ratio of their respective ownership interests, which are presently as follows:

Iowa Electric Light and Power Company	70%
Central Iowa Power Cooperative	20%
Corn Belt Power Cooperative	10%

8. The power produced by the unit will be shared by the applicant and the coapplicants in the ratio of their respective ownership interests.
