PROPOSED CHANGE RTS-150
TO
DUANE ARNOLD ENERGY CENTER
TECHNICAL SPECIFICATIONS

The holders of License DPR-49 for the Duane Arnold Energy Center propose to amend Appendix A (Technical Specifications) to said license by deleting current pages and replacing them with the attached proposed pages. A list of the affected pages is included.

This change is administrative and corrects an oversight which occurred when the Shift Technical Advisor (STA) was added to Table 6.2-1. The table requires that the STA be on duty anytime the reactor is not in a cold shutdown condition which implies that the STA must be on duty when the reactor mode switch is in Refuel. NUREG-0737, Item I.A.1.1 does not require the STA to be on duty during Cold Shutdown or Refueling for BWR's. By adding the additional note to Table 6.2-1, the requirement for a STA when the reactor is in the Refuel mode is deleted.

An additional asterisk is added to the SLO under the "Other Than Cold Shutdown" column to be consistent with the "Cold Shutdown" column.
