Dear Mr. Denton:

In the referenced letter, we requested a two year extension to Amendment No. 91 of our Facility Operating License No. DPR-49. Amendment No. 91 approved our Plan for the Integrated Scheduling of Plant Modifications for the DAEC (Integrated Plan).

In discussion with your staff, we understand that the Nuclear Regulatory Commission wishes to standardize the form of license amendments covering integrated plans. Accordingly, please revise our license to incorporate this standardized form by revising paragraph 2.C(6) to read as follows:

- 2.C(6) 1. The "Plan for the Integrated Scheduling of Plant Modifications for the Duane Arnold Energy Center" (the Plan) submitted on November 12, 1982 (as revised) is approved.
- a) The Plan shall be followed by the licensee from and after the effective date of this amendment.
- b) Changes to dates for completion of items identified in Schedule B of the Plan do not require a license amendment. Dates specified in Schedule A shall be changed only in accordance with applicable NRC procedure.
2. This license amendment shall be effective until May 3, 1987, subject to renewal upon application by the licensee.
