In reply to your letter of December 10, 1979, regarding our failure to report an approved guarantee of payment for deferred premiums for each of our operating nuclear reactor over 100 Mw(e) pursuant to Section 140.21 of 10 CFR Part 140, please refer to our letter dated November 5, 1979, which was filed by Iowa Electric Light and Power Company, Cedar Rapids, Iowa, on November 20, 1979. As 20% owner of the Duane Arnold Energy Center nuclear facility, our guaranteed premium is only a portion of the total, and therefore, all owners file this information through Iowa Electric.
