Dear Mr. Denton:

During the April 30, 1980 meeting between Iowa Electric and your staff concerning Emergency Planning, we indicated that we would submit a revised plan within 60 days. In order to minimize the question, response and resubmittal cycle, we have determined that 90 days is a more correct time frame.

We plan to submit our revised Emergency Plan by July 22, 1980. This letter confirms conversations with your Mr. Tom Kevern.

We had also discussed a delayed response to your letter dated March 7, 1980 concerning proposed Technical Specifications and documents pertaining to radiological effluent and environmental monitoring. We stated that our response would be delayed to properly integrate environmental monitoring requirements with the TMI related data monitoring requirements which are now in process. We intend to provide this response by June 27, 1980.
