
Dear Mr. Vassallo:

On December 28, 1983, this office received from Iowa Electric Light & Power Company a copy of its amendment (to Op License No. DPR-49) request dated December 21, 1983, relating to revisions in the 10-year Inservice Inspection (ISI) Program, and identified as proposed change RTS-143.

On March 12, 1984, this office received the monthly notice of amendment applications to operating licenses involving no significant hazards consideration. At 49 FR 7038 for February 24, 1984, the notice of the subject amendment request was included, and the basis of the NRC proposal for a no significant hazards consideration determination was explained.
