

The purpose of this letter is to document our need to revise the date of our response to your letter of July 28, 1982 concerning Relief and Safety Valve Test Requirements. Our letter of September 15, 1982 stated our intent to provide our response by October 29, 1982. This date was based on our plan to use generic information being developed by the BWR Owners' Group.

We have recently received the Owners' Group generic response and we have determined that further review is needed to complete our plant specific response. It is, therefore, our intent to provide our response by December 13, 1982.
