
Dear Mr. Vassallo:

On August 22, 1984, this office received from Iowa Electric Light & Power Company a copy of its amendment (to Op License No. DPR-49) request dated August 17, 1984. The request related to removal of the technical specification 1593 MWt limitation so the power level may be increased to the 1658 MWt that was originally established in the operating license. The request was identified as proposed change RTS-165.

On November 5, 1984, this office received the monthly notice of amendment applications to the operating license involving no significant hazards consideration. AT 49 FR 42825 October 24, 1984, the notice of the subject amendment request was included, and the basis of the NRC proposal for a no significant hazards consideration determination was explained.

This letter is to state that as the 10 CFR 50.91(b)(3) state consultation designated contact, I have no comment.
