
Dear Mr. Vassallo:

On September 26, 1985, this office received from Iowa Electric Light & Power Company copies of its amendment (to Op License No. DPR-49) request dated September 24, 1985. The request related to rearranging portions of DAEC plant staffing, DAEC site management and DAEC offsite management. The request was identified as proposed change RTS-190.

On December 5, 1985, this office received the monthly notice of amendment applications to operating licenses involving no significant hazards consideration. At 50 FR 47864 for November 20, 1985, the notice of the subject amendment request was included, and the basis of the NRC proposal for a no significant hazards consideration determination was explained.
