


The purpose of this modification is to (1) extend the period of performance through 31 March 2012 and (2) add incremental funds in the amount of \$21,600.00. Accordingly, this task order is hereby modified as follows:

Page 2, paragraph 2 of Task Order 9 is hereby deleted in its entirety and replaced with the following paragraph:

"Task Order No. 9 shall be in effect from 5/14/08 through 3/31/2012 with a cost ceiling of \$386,217.00. The amount of \$375,062.00 represents the estimated reimbursable costs, and the amount of \$11,155.00 represents the fixed fee."

Page 2, paragraph 3 of Task Order 9 is hereby deleted in its entirety and replaced with the following paragraph:

"The amount obligated by the Government in respect to this task order is \$382,100.00 of which \$371,064.00 represents the reimbursable cost, and the amount of \$11,036.00 represents the fixed fee."
