****CONTRACT MODIFICATION FOR CLAIM SETTLEMENT****

This purpose of this modification is to increase the contract's ceiling on the delivery order portion by \$8,255.43 from \$719,464.08 to \$727,719.51, in order to settle Ian, Evan, & Alexander Corporation's (IEA) claim associated with Invoice #4007 dated 01/04/2011. Sufficient funds exist on the contract to pay IEA's claim in the amount of \$8,255.43. Accordingly, the contract is modified as follows:

Under Section A.2 CONSIDERATION AND OBLIGATION – DELIVERY ORDERS (JUN 1988), Paragraph (a), Sentence One (1) is deleted in its entirety and replaced with the following:

"The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$727,719.51"

All other terms and conditions of this contract remain unchanged.
