PURPOSE: On July 27, 2011, a Title 10 of the *Code of Federal Regulations* (10 CFR) 2.206 petition (Agencywide Documents Access and Management System Accession No. ML11216A085) was submitted to the Nuclear Regulatory Commission (NRC) from the Natural Resources Defense Council (NRDC) requesting that the NRC order licensees to take action regarding various recommendations in the NRC Near-Term Task Force report, "Recommendations for Enhancing Reactor Safety in the 21st Century."
