The NRC staff has performed an acceptance review of LTR NEDC-33075P, Revision 7, and found that the material presented provides the technical information in sufficient detail to enable the NRC staff to proceed with a detailed technical review. The NRC staff expects to issue its request for additional information by November 17, 2011, and issue its draft safety evaluation by July 16, 2012. The NRC staff estimates that the review will require approximately 320 staff hours, including project management time, and the estimated contractor cost of \$28,900. The review schedule milestones and estimated review costs were discussed and agreed upon in a telephone conference between James F. Harrison, Vice President - Fuel Licensing and the NRC staff on August 16, 2011.
