His main interest is the protection of the plant from flooding, especially in light of the insights regarding flooding from the Fukushima Dai-ichi accident and the recent concern over a potential dam failure at Oconee. The Commissioner would also like Ben Beasley, RES Chief of the Operating Experience and Generic Issues Branch, to accompany him on the visit, due to Ben's familiarity with the potential Generic Issue on flooding following upstream dam failures.
