Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

Please note, as we discussed by telephone on June 27, 2011, we have not added the facility located at 6501 East 11 Mile Road, Warren, Michigan, as a location of use at this time because we need additional information as described in the enclosed, "Request for Additional Information". Please resubmit your request with the additional information to **mail control 575343**.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.



As we discussed on the telephone on June 27, 2011, we cannot add the facility at 6501 East 11 Mile Road, Warren, Michigan at this time because we need additional information to complete our review of this matter.

It is our understanding that you wish to make the facility located at 6501 East 11 Mile Road, Warren, Michigan, a storage facility, a Depot level maintenance and repair facility, and a training facility.

1. Licensed Materials

Please specify which items you wish to store, maintain, repair, and train personal. For example do you wish licensed items 6.A. through 6.C. as listed in item 11.A. of your current license?

2. Storage facility

- a. Please specify the level of storage for the items. For example, will the Warren Michigan be a bulk storage facility such as Pine Bluff Arsenal?? Will you only store a few items? Please clarify and explain.
- b. Please describe the storage facility.
- c. Please confirm that the storage facility will meet the requirements as described in Item 9. I. in your license application July 25, 2008.

- d. Please describe the training for personnel who work in the storage facility. For example, location of radioactive materials, responsibility to report any unusual occurrence involving stored radioactive materials, what to do in an emergency situation, etc.

3. Depot Maintenance Facility

- a) Please specify which items you wish to repair and maintain. Please confirm that items will only be repaired and maintained as allowed by the Sealed Source Device Registries.
- b) Please describe the depot maintenance facility.
- c) Please confirm that the depot maintenance facility will meet the requirement of a tritium instrument repair room and a maintenance facility as described in item 9 II "Maintenance Facilities" in your license application dated July 25, 2008.
- d) Please describe the training program for individuals who will repair and maintain the devices.

Training Facility

- a) Please describe the items that individuals will be trained to repair. Please confirm that items will only be repaired and maintained as allowed by the Sealed Source Device Registries.
- b) Please describe the training facility.
- c) Please confirm that the training facility will meet the requirements for the activities the individual will be trained to perform. For example, if the individual is to repair a tritium fire control device containing self luminous lamps, the facility will be a Depot level facility with a tritium instrument repair room, etc.

- d) Please describe the training an individual will receive for the specify activity he is to perform and confirm that items will only be repaired and maintained as allowed by the Sealed Source Device Registries.

- e) Please describe the qualifications, training, and experience of instructors. For example, individuals who will train others will be a Depot facility RSO, have received military occupation specialty training for the specific device from U.S. Army Chemical School (or specialty school for that device), and has had "hands on" training and experience, etc.
