This report is submitted in accordance with the requirements of Appendix B to Operating License DPR-49, Specifications 4.3.1.C and 5.4.2.1.

Paragraph 4.3.1.A of Appendix B does imply that allowances are made for not obtaining environmental samples due to infrequent events and unavailability of samples. However, after conferring with Region III compliance personnel, it was decided that this report should be submitted due to the specific detail information stated in section 4.3.1.C of Appendix B.

Problem

The milk farm location #64 listed in table 4.3.1 will discontinue providing milk samples for our environmental program. The milk samples will be unavailable after June 15, 1976.

Investigation

Upon notification of the milk sample unavailability, another milk farm has been contacted for milk samples. This farm will be designated as #97 and is located in the same sector as farm #64.

Corrective Action
