In Reference 1, Exelon Nuclear Texas Holdings, LLC (Exelon) submitted responses to NRC staff questions included in Request for Additional Information (RAI) Letter No. 06, dated March 31, 2011, related to the Victoria County Station (VCS) Early Site Permit (ESP) application. The response to NRC RAI Question No. 13.03-34 stated that Exelon is working with Calhoun County to determine and incorporate a portion of the county into the VCS plume exposure pathway Emergency Planning Zone (EPZ), and provided a commitment to submit the Emergency Plan documentation reflecting the addition of Calhoun County by August 15, 2011. Additional time is needed to complete the required Emergency Plan documentation for Calhoun County. As a result, Exelon plans to provide this documentation to support the response to RAI Question 13.03-34 by September 15, 2011.

The revised regulatory commitment described above is identified in Enclosure 1.
