Dear Mr. Hankins:

On April 29, 2011 - August 17, 2011, Randolph Ragland of this office conducted a security inspection of your activities authorized by the above listed NRC license. The inspection was conducted as an in-office review because during the time period of the inspection, you were not actively working in areas under NRC jurisdiction. The inspection was limited to a review of your access controls and monitoring of radioactive material in quantities of concern while in areas under exclusive federal jurisdiction. Information was gathered during the inspection through telephone interviews, electronic mail correspondence, and through a review of background screening records received in a FedEx package dated June 20, 2011. The findings of the inspection were discussed with you by telephone at the conclusion of the inspection on August 17, 2011.

Based on the results of this inspection, the NRC identified security-related violation(s), which are documented in the enclosed Notice of Violation (Notice). The violation(s) were evaluated in accordance with the NRC Enforcement Policy and are categorized at Severity Level (SL) IV. The Enforcement Policy is included on the NRC's website at www.nrc.gov; select **About NRC; Regulation; Enforcement; then Enforcement Policy**. The violation(s) are cited in the enclosed Notice of Violation (Notice), because the violation was identified by the NRC. Information regarding the basis for significance determination for the violation(s) is addressed in Enclosure 2.

You are required to respond to this letter and should follow the instructions specified in the enclosed Notice when preparing your response. For your consideration, we suggest that you review NRC Information Notice 96-28, "Suggested Guidance Relating to the Development and
