Dear: Mrs. Baltes

This refers to your letters dated December 21, 2010, and May 4, 2011, requesting termination of NRC license No. 13-32694-01.

**This also refers to the telephone conversation between Dr. Thomas P. Ryan and me on July 12, 2011, concerning the status of the termination request, the remaining deficient items to be resolved, and a fees question he had.**

**In your letter dated May 4, 2011, you stated that "Any radiation safety issues, if they would have occurred, would have been addressed by Dr. Ryan who continues to be available for such needs as the RSO."**

**As Dr. Ryan called me and left a voicemail message on July 12, 2011, I returned his call. Dr. Ryan also asked me about questions pertaining to your annual Fees invoice from NRC and I referred him to one of our Fees specialists in our headquarters offices, Ms. Rosalyn Jones, at (301) 415-7300.**

**Please note that we cannot approve your request at this time because the information in your letters dated December 21, 2010, and May 4, 2011, was insufficient to complete our review.**

**If you wish to pursue this request please provide a written, currently signed and dated response to the items below, within 15 days of the date of this letter, addressed to my attention as "additional information to control number 575086," to facilitate proper processing in our offices. We will then continue our review.**

**However, if you will be unable to respond by this date, please contact me at (630) 829-9841 to make alternative arrangements. My fax number is (630) 515-1078. Please call me and at least leave a voicemail message for me if you fax a response in so that I can check to ensure it arrived here.**

**If I do not hear from you by July 27, 2011, it may be necessary to void this request again without attempting to contact you further. "Void" means that we would be taking this request out of our active database until we receive an appropriate written response.**

**My letter to you dated March 23, 2011, requested that you submit a copy of the final leak tests performed on your sealed sources. Your letter dated May 4, 2011, failed to provide this information.**

**Please provide a copy of the final leak tests performed on your sealed sources to demonstrate that they were not leaking at the time of transfer. Only the final and most recent leak tests need to be submitted.**

**My letter to you dated March 23, 2011, requested that you provide a copy of the final waste disposal records. 10 CFR 35.92, 35.2092 and 10 CFR 30.35(g) require this information.**

**Your letter to me dated May 4, 2011, stated, "The final waste disposal records are packed in boxes in anticipation of the termination. These records remain in the possession M. Baltes as indicated in the original request for termination." The requested records were not provided.**

**Please provide a copy of the final waste disposal records, for materials decayed-in-storage. Please provide only the last and final copy.**


