<u>Noncompliance (50-331/81-25-12c)</u> - Fire Brigade Fire Fighting Practice Sessions:


We have changed our procedures to include the requirement for the practice sessions as specified in the guidelines, "Nuclear Plant Fire Protection Functional Responsibilities, Administrative Controls, and Quality Assurance".

We are working with Iowa State University - Fire Service Extension to formulate a program to provide this training annually. These practice sessions are tentatively scheduled to commence in July, 1982 with expected completion by all fire brigade members by November, 1982.

Noncompliance (50-331/81-25-12e) - Preplanned Fire Fighting Strategies:

The DAEC Fire Plan presently contains area fire plans to be utilized as fire strategies. However, in reviewing these plans against the guidelines, "Nuclear Plant Fire Protection Functional Responsibilities, Administrative Controls, and Quality Assurance", the need for upgrading these plans has been identified.
