As requested in Mr. Roger S. Boyd's letter of January 26, 1973, we have made a review of the control circuits of all safety related equipment at the Duane Arnold Energy Center. This review has assured us that disabling of any one of a set of redundant components will not render the other component of that set inoperable, as was the case in the incidents cited.

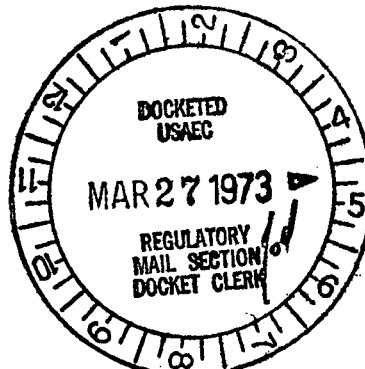
Additionally, our operating procedures will provide that whenever part of a redundant system is removed from service, the portion remaining in service will be functionally tested immediately after disabling the affected portion.
