Dear Mr. Keppler:

With respect to your request in the referenced letter for our interim measures to be put into effect until the DAEC Fire Plan is fully implemented, the following information is provided:

- a) Plant personnel will be assigned to a fire brigade team by May 1, 1976.
- b) By May 1, 1976 we will conduct a fire training session with the plant fire brigade.
- c) Personnel will be assigned responsibility for the coordination of a fire brigade by May 1, 1976.
- d) Criteria for various fire extinguishers and nozzles to be used for various types of fires will be established by May 1, 1976.

With respect to your request in the referenced letter to re-evaluate the date for full implementation of the DAEC Fire Plan, the following information is provided:


- a) The DAEC Fire Plan will be approved for use on July 1, 1976. This date is the same date as stated in our letter dated January 7, 1976.
