Gentlemen:

This is to acknowledge Mr. Wallace's letter dated August 25, 1977, informing us of a delay of up to four months in your schedule for fully implementing the requirements of WASH Documents 1283, 1284, and 1309. Your letter dated June 3, 1976 established the date of September 1, 1977 for meeting the above commitment. Your revised schedule establishes January 1, 1978 for final incorporation of all requirements into your plant operations.

We wish to point out that during our inspection in January 1977, we advised you that, based on our review, your progress in this area was not commensurate with full implementation by September 1, 1977. Our concern at that time was the need for early review of procedures relating to the WASH document requirements, particularly the Quality Assurance Directives.

As a result of the above delay, you are requested to provide us within twenty days your plans for monitoring progress to prevent further schedule slippages.

Should you have any questions concerning this matter we will gladly discuss them with you.

Dear Mr. Keppler:

In the referenced letter, we outlined our program for implementing the provisions of WASH Documents 1283, 1284 and 1309. The letter also stated that we anticipated full compliance with the WASH documents would be achieved by September 1, 1977. In an effort to satisfy the requirement for prompt implementation of the WASH documents, it has become apparent that we were overly optimistic in our original estimate of the amount of time required to adequately revise and implement the appropriate procedures. Therefore, this letter is to advise you that we anticipate a minor delay in achieving full compliance with the WASH documents.

In our review of plant operations to ensure compliance with WASH documents, five areas have been identified as requiring significant review and rework: control of plant work and work inspection, warehousing, nonconformance control, records management, and procurement. A prerequisite to implementing WASH document requirements in the above areas was a comprehensive review of Quality Assurance Directives and plant Administrative Control Procedures. The review of the procedures and incorporation of necessary changes is nearing completion. However, additional time will be required to adapt plant operations to the revised procedures.

Our revised schedule for full implementation of the WASH documents is as follows:
