Enclosed is Amendment No. 04 to your NRC Material License No. 21-32621-01 in accordance with your request. Please note that the changes made to your license are printed in **bold font**.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

Please note that we removed License Condition No. 13 from your NRC Materials License. The Troxler Electronic Laboratories Model 3400 Series gauges do not have the capability to extend 3 feet below the surface of the ground; therefore this condition is not required to be in your license. This change required us to renumber subsequent license conditions.

NRC's Regulatory Issue Summary (RIS) 2005-31 provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS, the NRC's electronic document system. Pursuant to NRC's RIS 2005-31 and in accordance with 10 Code of Federal Regulations 2.390, the enclosed license document is exempt from public disclosure because its disclosure to unauthorized individuals could present a security vulnerability. 
