American Society of Mechanical Engineers (ASME) Code Meetings in Boston

During the week of August 8, 2011, staff attended the ASME Section III and Section XI meetings held in Boston, Massachusetts. The primary topic of interest during this meeting was Code Case (N-755) on the use of Polyethylene material for underground service water piping that ASME developed about three years ago. The staff didn't endorse Revision 1 of this Code Case and indicated that it would not endorse Revision 2 either due to a variety of technical concerns that remained unresolved from Revision 1.

Acceptance of License Renewal Application (LRA) for Limerick Generating Station

On August 12, 2011, staff completed the acceptance review of the LRA for Limerick Generating Station, Units 1 and 2 (Limerick). The staff determined that the application contains sufficient information for docketing. On June 22, 2011, the staff received the LRA from Exelon Generation Company, LLC, requesting the extension of the operating license for an additional 20 years beyond the current 40-year term. Limerick, Units 1 and 2, are boiling-water reactors designed by General Electric with current operating licenses that expire at midnight on October 26, 2024, for Unit 1, and June 22, 2029, for Unit 2. The staff plans to hold public information sessions at Limerick, Pennsylvania, on September 22, 2011, to describe the license renewal process and to accept scoping comments for the environmental review. Acceptance of the LRA, which is published in the *Federal Register*, begins a 60-day opportunity for members of the public to file a request for hearing and/or petition to intervene.

Public Meeting with General Electric Hitachi (GEH)

On August 15, 2011, the staff participated in a public meeting where GEH discussed its plans to produce radioactive medical isotope Molybdenum-99 in operating commercial boiling-water reactors. GEH and its client licensee addressed NRC staff comments and concerns as GEH provided technical content, conceptual designs, and licensing schedules for this project.

Meeting with U.S. Department of Transportation (DOT) Pipeline and Hazardous Materials Safety Administration (PHMSA)

On August 16, 2011, staff met with personnel from the DOT PHMSA to discuss DOT regulations and guidance associated with the use of guided wave ultrasonic testing techniques to monitor buried piping in gas and hazardous material applications. PHMSA provided a summary of their 18-point guideline to guided wave inspection. Also reviewed were limitations of the guided wave techniques and the experience base that PHMSA has with its use. Guided wave inspection has recently been used in nondestructive examinations of buried piping at nuclear facilities, and licensees are considering further expansion of its use.

Public Meeting on Design Features

On August 17, 2011, NMSS staff met with representatives from the Nuclear Energy Institute (NEI), fuel cycle licensees, and applicants to discuss their proposed approach on the use of bounding assumptions and design features for risk assessment in integrated safety analyses. During the meeting, NMSS staff discussed the proposed approach and asked questions to better understand the industry's proposal. After much discussion, NMSS staff indicated that they will evaluate the information submitted by the industry and NEI, along with the meeting discussions, to establish the appropriate path forward. No regulatory commitments were made during the meeting. Meeting slides are available in the NRC's Agency-wide Documents Access and Management System at Accession Number ML112280625.

Technical Assistance in Support of Licensing Activities

On August 15, 2011, as a result of a noncompetitive acquisition, a cost-plus-fixed-fee type contract (NRC-HQ-11-C-03-0058) was awarded to Southwest Research Institute of San Antonio, Texas, to provide technical assistance in support of probabilistic risk assessment, fire protection, and accident dose assessments licensing activities related to nuclear reactor regulation. The period of performance is August 15, 2011, through September 28, 2012, with three 1-year option periods. The total value of the contract is \$983,228.00, inclusive of all options.

Nuclear Information and Records Management Conference

From August 15-17, 2011, the Deputy Executive Director for Corporate Support (DEDCM) from the Office of Executive Director for Operations, and staff from OIS and the Office of Nuclear Security and Incident Response (NSIR) participated in the 2011 Nuclear Information and Records Management Association Conference. The DEDCM made the keynote speech at the 35th anniversary function. The speech covered current topics at NRC including new licensing, responding to Fukushima, and information management challenges. NSIR staff discussed the NRC incident response program and the NRC actions following the Fukushima event. OIS staff made presentations on NRC's records modernization activities. Presentations attended by staff covered topics such as the use of SharePoint to manage records, capturing knowledge management in documents, document control fundamentals, e-discovery and document management, plus other records management topics.

Controlled Unclassified Information (CUI) Working Group Meeting

On August 18, 2011, staff from the Information and Records Services Division, the Office of General Counsel, and the Office of Commission Appellate Adjudication attended a CUI Working Group meeting at the Office of the CUI Executive Agent (EA). This was the second of weekly meetings to take place until early October 2011, during which agencies will work to standardize for common use across the Federal government the numerous proposed CUI categories and sub-categories that the EA received from agencies in May 2011. At this meeting, the EA briefly discussed the revisions to the two categories ("Patent" and "Copyright") discussed at the meeting on August 11, 2011. Subsequent discussion centered on the authorities in law, regulation, and government-wide use for the many subcategories that fall under the "Legal" category. The EA will use the discussions and subsequent email input from agencies to further standardize and refine the "Legal" category and subcategories. The next meeting, on August 24, 2011, will address the "Privacy" category and subcategories.
