
Dear Dr. Murley

In Reference 1 we submitted Technical Specification Change Request (RTS-229) for the Duane Arnold Energy Center (DAEC). This RTS proposed to remove cycle specific parameter limits from the Technical Specifications in accordance with Generic Letter 88-16, "Removal of Cycle Specific Parameter Limits From the Technical Specifications".

RTS-229 was issued as Amendment 167 to Facility Operating License No. DPR-49 (Reference 2). This Amendment removed cycle specific operating parameters from the Technical Specifications and incorporated Technical Specification section 6.11.2 which requires that such limits be established for each reload and incorporated into the Core Operating Limits Report (COLR). The report must be provided upon issuance to the NRC. Accordingly, we have enclosed the COLR for Cycle 11 operation of the DAEC.
