VIETTI-COOK: The Commission is being asked to act on a final rule amending certain emergency preparedness requirements in the regulations that govern the domestic licensing of production and utilization facilities. Among other things, the final rule adds a conforming provision that governs licenses, certifications, and approvals of new nuclear power plants; codifies certain voluntary protective measures and generically applicable requirements similar to those previously imposed by Commission orders; enhances the ability of licensees to implement certain emergency preparedness and protective measures in the event of a radiological emergency; and addresses security issues identified after the terrorist events of September 11, 2001.

The Commission has voted to approve the publication and implementation of this final rule, subject to the comments and changes in the attachment. Would you please affirm your votes?
