SUBJECT: APPLICATION FOR NRC IMPORT LICENSE (IW030)

Enclosed for your consideration is an application dated August 1, 2011 (Enclosure 1), from GE Hitachi Nuclear Energy, LLC requesting a license (IW030) to import up to 210 used Cobalt-60 radioactive sealed sources from China. We are sending analogous letters to Mr. Gary Butner (State of California), Ms. Susan Jablonski (State of Texas), and Mr. Michael Ford (Texas Low-Level Radioactive Waste Disposal Compact Commission), for their respective consideration.

The latest import application (IW030) was forwarded to the U.S. Department of State (DOS) on August 16, 2011, for assistance in notifying Chinese Government authorities of the proposed radioactive waste import. NRC also requested DOS's views as to whether approving the application would be consistent with the guidelines of the Joint Convention of the Safety of Spent Fuel Management and Safety of Radioactive Waste Management.

NRC published a Federal Register notice regarding the import license application on August 30, 2011 (Enclosure 2). GE Hitachi Nuclear Energy, LLC (Vallecitos Nuclear Center) will use their California license to recycle the sources to the extent possible, perform forensic testing and store the remainder for waste disposition (potentially at Waste Control Specialists LLC in Texas).

It would be greatly appreciated if within three weeks of the date of this letter, you could respond with any comments you may have concerning the import license application (IW030), or if necessary, provide an estimate of how much additional time may be required to complete your review and provide a written response to NRC.
