Hi Rich – Jon is away until Monday. If you can wait until he returns, he should be able to provide you all the information you need. If you need something before then, you can use the summarized feedback below. Note that it is tentative. We are meeting with the Commission TAs on September 3rd to inform the Commission of the details of the proposed revised schedule. The ACRS meeting went very well. Apart from some very good insights on how we can better coordinate our uncertainty analysis with the public release of the SOARCA documents, there were no takeaways.

- January/February 2011 timeframe for public release (for review and comment) of the draft NUREG and for public meetings near the sites.
- Peach Bottom and Surry will be notified in advance before the documents are actually released.
- Final ACRS meeting will be in the May/June 2011 time frame.
- Final NUREG to Commission in June 2011.
- The last ACRS meeting (June 2010) went pretty good.

May not be a bad idea to share this with the Surry PM as well.
