Research is seeking participants to take part in the state-of-the-art Consequence Analysis (SOARCA) project. Surry and Peach Bottom were selected earlier this year and have actively participated by providing, on a voluntary basis, site-specific information to support the project. Completion of these two sites are projected for Fall 2007. They would now like to reach out to other possible volunteers (namely, Calvert Cliffs, TMI-1, and Susquehanna) to assist/support remaining information needs of the project (completion of the entire project is targeted for Fall 2008).

Requested Please contact your licensing POCs and set up an "Information Call" for this week. RES will lead the discussion, provide background of the project, and request your licensees to participate. I am the NRR/DORL SOARCA POC and will be coordinating the SOARCA effort w/plant PMs and RES. With all the emails in the past week or so, I'd like to recap on where we stand with securing pilot plants for SOARCA. With Sequoyah onboard, we need two more plants to achieve the five we committed to in the revised project plan with the Commission. We need to know right now whether Grand Gulf will volunteer or not. I will assume they will not. It is time to talk to other plants on the list. We need to engage Susquehanna, Calvert Cliffs and TMI-1. I'm not sure if my last email stated this, but we need to contact the three plants now. Brian Sheron has asked to be informed on whether we have the complement of five or not so he can engage the OEDO. By the 17th of August I need to be able to tell him whether I have the plants or not. Please keep Bob Prato and Jason Schaperow in your planning and scheduling of the calls. Regarding Sequoyah, we need to have a conference call right away to get things going. To summarize:

- 1) Grand Gulf Need to know their decision
- 2) Seguoyah Need to have a conference call to discuss the needs and site visit.
- 3) Susquehanna Need a conference call to solicit participation
- 4) Calvert Cliffs Need a conference call to solicit participation
