

## **REMOVAL OF FACILITY AS AN AUTHORIZED USE OR STORAGE LOCATION**

In May 2011, Lilly finalized an agreement by which a portion of Lilly's ADME research was outsourced to Advion BioSciences (Advion). At this time Advion does not hold a license to use radioactive material in the state of Indiana. In lieu of delaying research, Lilly agreed to amend its broadscope license to include the Purdue Technology Center location. The addition of the Purdue Technology Center to Lilly's license was approved per Amendment 64 in March 2011 and was completed with the understanding that Advion would obtain a license from the NRC in a timely manner for activities at the location. Advion submitted a license application on June 24, 2011.

The facility opened in May 2011 and Advion personnel have been using C-14 in small quantities under the Lilly broadscope license since that time. Per Lilly's license requirements, surveys have been conducted monthly to ensure that no contamination is present. Since Advion will continue the use of radioactive material at this location, Lilly will not be conducting any close out surveys or decommissioning. However, Lilly will provide copies of all required surveys that have been performed for each lab or area where radioactive materials have been used under its license, 13-01133-02, to Advion. Additionally, dosimetry has been provided by Lilly to all Advion employees who are approved to work with radioactive

material. The dosimetry provided by Lilly will be discontinued and monitoring will be determined by Advion. If requested, Lilly will provide dosimetry records to Advion personnel. Lilly has observed no radiation dose for the majority of individuals who moved to Advion. The individuals where some dose was observed received 10 mrem or less.

Concurrent with the application approval for Advion, Lilly is requesting that the facility at Purdue Technology Center, 5225 Exploration Drive, Indianapolis, IN 46241, be removed from Lilly's license.
