Steve,

Please consider the possibility of a meeting between the Luminant COLA team and the NRC staff review team to discuss the hydrology audit open issues. Luminant intends to provide supplemental information starting in late August through mid September. I suggest that 5 to 6 weeks after we file our last supplement, that we meet with the NRC staff to discuss the issues and see if any clarifications are needed and see if we can close the issues. This gives the staff time to review the information prior to the meeting so that we can have a meaningful meeting.

Please let me know if this seems like a reasonable plan. We have done some checking on availability of the Luminant team and have found that October 27 and the week of October 31 seem to be available. I am trying to get the ball rolling on this very early because I know how everyone's calendar fills up. I have added this item to our talking points and we can discuss further during our weekly COLA conference calls.
