NRC staff contacted the licensee to clarify the following information provided in an amendment request letter dated August 18, 2011:

1. The documentation (NRC Form 313A) submitted for AU training and experience and preceptor attestation under the T&E pathway provides some conflicting and missing information:
  - a. The form indicates a request for individual authorization for each of the four categories under 10 CFR 35.300 uses but indicates 35.390 under classroom and lab training, supervised case work experience, and preceptor attestation, rather than 35.392 and 35.394. The form also indicates total hours of training for class and lab training as 139 hours.  
The license reviewer explained that based on the current information provided in the request, the proposed AU can either be authorized for uses under 35.392 and 35.394 via the T&E pathway, or uses under 35.390, with the exception of the fourth category, if they show a minimum of 200 hours of classroom and lab training.
  - b. The form indicates use under the fourth category of 35.300, "parenteral administration of any other radionuclide". The license reviewer informed Mr. Solge that there are no known clinical uses that fall under this category at this time, and as such, Dr. Erin will not be authorized for uses that fall under this category.
  - c. The total number of hours of supervised case work experience over the span of the 3 years was not provided on the NRC Form 313A.

Mr. Solge agreed to submit a revised NRC Form 313A with the necessary revision as soon as possible.
